In order to be eligible for co-option as a Town Councillor you must satisfy certain criteria. You must satisfy a. and b. below and at least one of the options c. to f.

a. I am 18 years of age or over	
b. I am a British citizen, an eligible Commonwealth citizen, a citizen of the Republic of Ireland, a qualifying EU citizen or an EU citizen with retained rights	
c. I am registered as a local government elector for the Town at the above address	
d. I have, during the whole twelve months preceding this application occupied, as owner or tenant, land or other premises in the Town.	
e. My principal or only place of work during those twelve months has been in the Town.	
f. I have during the whole of those twelve months resided in the Town or within three miles of it.	

Under Section 80 of the Local Government Act 1972 there are some reasons why a person is disqualified from being a Town Councillor, including these reasons:

I confirm that (please tick **all** which apply to you):-

i. I am not employed by the Town Council or hold paid office under the Town Council;	
ii. I am not employed by an entity controlled by the Town Council;

iii.	I am not the subject of a bankruptcy restrictions order or an interim bankruptcy restrictions order or a debt relief restrictions order or an interim debt relief restrictions order;	
iv.	I have not within five years prior to this application, been convicted in the UK, Channel Islands or Isle of Man of any offence and been sentenced to imprisonment (whether suspended or not) for not less than three months without the option of a fine;	
v.	I am not otherwise disqualified under Part III of the Representation of the People Act 1983 (relating to corrupt or illegal electoral practices and offences relating to donations) or the Audit Commission Act 1998.

The information will be treated as confidential by the Council and Councillors and will not be retained after the co-option meeting unless your application is successful, when it will be destroyed after six months.
